### 4. Matters Arising

Nothing of note, other than the telephone system which has been installed and is now embedded.

## 5. Plas Meddyg Brief - Mark

MB provided the following:

## a. Surgery News

- Dr Wright will be officially leaving us on 03/08/2022, however he has been persuaded to do some locum sessions for us for the next couple of months so you may still see him about.
  - JG are there any concerns around continuity of care? MB no formalised handover other than a few patients with very complex issues but no real concerns.
- Dr Fraz Chaudhry and Dr Sanji Lalchan will be joining us on 04/08/2022 under Dr Stokes' wing.
- There has been a lot of reception staff illness over the last two weeks and that combined with annual leave has meant they have been stretched.

The committee briefly debated whether any mitigating measures could be put in place to prevent lone receptionist working during sickness e.g. extra staff, volunteers, using email.

### b. Telephone system

We had our new telephone system installed on 27/06/2022. Lots of features including highlighting how many incoming calls we do get -450 on two recent Mondays so that will help us plan staffing levels.

#### c. Covid-19 Booster vaccinations

- ➤ Groups: 50+, 5-49 in clinical risk group including pregnant women, 5-49 who are household contacts of people with immunosuppression, 16-49 who are carers, care home residents and staff, frontline health and social care workers.
- Yet to be announced when and how eligible groups will be able to get their autumn boosters.

- Likely to be at Plas Meddyg rather than at our PCN-designated site Bursted Wood Surgery.
- Expect it will be our Nurses vaccinating the housebounds.

#### d. Flu vaccinations

- ➤ 65+. Half delivered w/c 26/09, other half w/c 17/10
- ➤ Housebounds. Expecting them to be given by District Nurses as per previous years. They use our stock but don't usually get going until end October, November.
- ➤ 2-3 year olds will be done at the surgery when receive nasal flu stocks.
- School-aged children that are eligible (more ages this season than last) are given in school.
- Under 65 in a clinical risk group, pregnant women and frontline healthcare workers. Delivery expected early-mid October.
- ➤ 50-64s not in a clinical risk group. This has been on-off-on so we are now ordering supplies. Likely to be after the at-risk groups.
- ➤ Hopefully, some flu vaccinations can be given at the same time as Covid-19 autumn boosters but will depend on what stocks are available and when!

### e. Patient Survey

Results just circulated and some details attached. All practices have to produce a plan to improve the results and I am aiming to bring this to the next meeting for the PPG to consider/debate. (See below)

### f. Extended Access

- Planning is well under way on this within our PCN. The CCG (or ICB as it is now known) has been gauging what patients would like but unfortunately this has only recently begun so it may not influence the service as much as we would all have liked.
- ➤ It looks like our PCN, "APL Bexley PCN" will open on Saturdays on a rotational basis so, for example, Plas one week, then Albion, then Bursted, Lyndhurst, then back to Plas etc. Patients from all our PCN's practices will be seen on each Saturday, however we will be trying to share out the appointment slots based on our respective list sizes, so, Albion as having approximately 50% of the PCN's patients will have 50% of the slots initially allocated to them. If there are unbooked appointments nearing the clinic date then these slots will be opened up to the other practices.
- ➤ Likely to be Saturdays 9am 5pm with a doctor, nurse and reception staff. Individual practices will continue with their current extended (before 8am and after 6.30pm) weekday hours which counts towards the 36 hours that we are paid to provide as extended access hours 1 hour/week/1000 patients.
- Requires an enhanced clinical system and multiple data sharing agreements so that consultations can be recorded straight into patient records regardless of which practice they are registered with. Bexley have purchased this and I am on the implementation group.

MT- how has it been decided what the set-up will be for the PCN? MB – clinical directors have discussed and come up with the above plan.

There was some concern this would stretch Plas resources further but MB thought 2 receptionists per month should be workable. MT commented the system of phoning at 8am to be triaged for a duty doctor works very well.

JG – what will the process be to book on a Saturday? MB – the usual, phone or book into slots.

#### 6. Patient Engagement

Delay due to some "technical" communication hitches. MS sent a draft letter to MT for covering words for the survey. MT confirmed this was ok.

ACTION: MT to forward words for covering letter to MB; JG to send MB the survey link. MB to email James Green for the Google survey form. Survey to be sent first week in September to allow for school holidays and annual leave during August.

## 7. Update on G P Practice Survey - Mark

As covered in item 5f. CCG (Clinical Commissioning Group, now the ICP – Integrated Care Partnership) asked Plas to send out a survey to patients to see what they would like for extended access. The survey was sent quite late so it was doubted if many responses would be considered for the initial set up of the service. PCN (Primary Care Network) is pushing for appointments on a Saturday morning.

#### 8. PPG discussion and the future.

Patient Engagement work to continue. Survey to be sent to 50 patients from each age band.

### 9. AOB

a. MT – Leanne Midwinter was asked by Mr Downs if they could join the PPG directly. There is no waiting list and no-one else has come forward to join the Committee rather than the virtual members.

ACTION: MT to write to and meet Mr Downs.
